

as member for Clonmel, but his position in it, always insignificant was now one of obscurity. In Feb. 1857, he quitted public life on receiving from Lord Carlisle, the Clerkship of the Hanaper office of Ireland; and on 28 May, 1858, he died suddenly at his house at Gowran Hill, Kingstown, Dublin, where he had lived for some years, and was buried at Glasnevin Cemetery. He published a wordy and extravagant *Life and Speeches* of his father in 1846, which was republished in 1854, and *Recollections* of his own parliamentary career, a chatty but unsatisfactory book, in 1846, which was fiercely attacked in the *Quarterly Review* (lxxxvi. 128).

John was educated Clongowes College and T.C.D. 1 Dec. 1828.

Elizabeth, Mrs. (John) O'Connell, was the dau. of Dr. James Ryan, of Jubilee Hall, Bray, co. Dublin, by his wife Ellen, dau. of Mark MacMahon, merchant of Dublin. Dr. James Ryan was the son of Charles Ryan, Esq. (b. 1747; d. 1810). This Charles Ryan was the grandson of Thomas Ryan, of Holycross, co. Tipperary (b. 1673; d. 1731). Thomas's grandfather owned a large property near Holycross, confiscated under Cromwell. When the Cromwellian planter took possession, he was so struck by the bearing of the forfeiting proprietor that he allowed him £25 a year for life.

- C1 John O'Connell, M.P., and Elizabeth, his wife, had eight children, grandchildren of the Liberator, i.e. Daniel John O'Connell (C2A), John O'Connell, M.I.C.E. (C2B), Captain Morgan J. J. O'Connell (C2C), Elizabeth Mrs. Sullivan (C2D), Mary Mrs. Comyn (C2E), Kathleen Mrs. Balfe (C2F), Miss Eily O'Connell (C2G), and Miss Alice O'Connell (C2H). Their descendants are as follows:
- C2A Daniel John O'Connell, *b.* — 1839; educated National University of Dublin; drowned in a boating accident in Kingstown Harbour 1 June, 1872; *unm.* but engaged to be *m.* at the time, *d.s.p.*
- C2B John O'Connell, *b.* 26 Feb. 1843, and trained as a civil engineer. He gained his experience at Wexford Harbour and on the Dublin Corporation Water Works. In 1868 he received an appointment to the staff of Bombay, Baroda and Central Indian Railway, and after assisting on the construction of the Wadhwan, Dakor and other lines, he was promoted, in 1877, to resident engineer, in which capacity he held executive charge of about 250 miles of open main line, and of the Godhra branch, on which he carried out, departmentally, the construction of a low level viaduct of 65 spans across the Mahi River. In 1882 he was appointed to take charge of a district of about 350 miles of open line, way and works, and later for a time held charge of the Bombay district, including the construction of several large stations, the strengthening of the Bessein creek viaduct and the construction of a large portion of the line washed away by the mousoon floods of 1884. In 1889 he was forced to retire and leave India on the grounds of ill-health, and thereafter lead a very retired life at his house at Kilkenny, where he *d.* 4 July, 1905, aged 62. He was elected A.I.C.E. 4 April, 1876, A.M.I.C.E. and M.I.C.E. 15 Jan. 1889. He *m.* — 1873, Mary, dau. of Mr. Justice Henry Baldwin, Q.C., Judge of the Leinster Circuit and of Appeals, by Mary Grehan, his wife, She died in 1907. She was heraldically probably a co-heir with her sisters Elizabeth Mrs. Lawless (d. 1893), Frances Mrs. Sherlock, of Swords, wife of a Dublin doctor, Margaret Mrs. Galwey, of London, and Miss Nan Baldwin, later a widow living at Bristol. They had issue four children, Dr. John (C3A), Daniel J., of Seattle (C3B), Henry, of Hoylake (C3C), and May, Mrs. Rickards (C3D).
- C3A Dr. John Henry O'Connell, *b.* — 1875, of 190 Upper Parliament Street, Liverpool; *m.* 15 July, 1903, Mary, eldest dau. of William Lambert Burke, of Tyaquin, co. Galway. Her brother, Major John Burke, M.C., M.D., *m.* Emily Hayes [E3E7 herein]. Dr. O'Connell *d.* 4 May, 1940. Mary Mrs. O'Connell was *b.* in 1877, and *d.* 20 Jan. 1939, having had issue,
- C4A John O'Connell, *b.* 14 Jan. 1905; *d.* *unm.* 21 March, 1927.
- C4B Margeretta May O'Connell, *b.* June, 1906; a civil servant.
- C4C Donal, *b.* 1908; joined the Marist Order in Australia, as a lay-brother—"Brother Brendan." Alive 1946.
- C4D Morgan O'Connell, *b.c.* 1909; Royal Artillery; *unm.*
- C4E Sheila O'Connell, *b.* 22 Oct. 1910; *m.* 2 Feb. 1939 at the church of the Sacred Heart, Hampstead, London, Major W. Hugh Harold, R.H.A.(T.), son of the late Mr. W. H. Harold, of Wallasey. Major Harold was a prisoner in Germany, 1944-5.
- C4F Hubert O'Connell, *b.* 20 Oct. 1913, of the Royal Air Force; *m.* at Huckall, Notts, in Oct. 1939, Constance Williams, and has issue,
- C5A Theresa Mary O'Connell, *b.* May, 1941.
- C4G Nora O'Connell, *b.* 12 Feb. 1920; 3rd officer W.R.N.S.
- C3B Daniel J. O'Connell, of Seattle, U.S.A., *b.* at Ahmadabad, 20 Nov. 1879; educated Blackrock College, Dublin, 1892-4; H.M.S. Conway 1894-6, in sail 1897-1904, in steam 1904-11, officer in the Pacific Steam Navigation Coy., and subsequently in R.M.S. *Empress of Ireland*, C.P.R. service; resigned in 1911, at Vancouver, and entered a stevedoring company; 1914 moved to Seattle, where he was engaged in same business in Aug. 1946. He *m.* on 18 Feb. 1909, Elizabeth A. Leyne, dau. of Captain G. Leyne, City of Cork Steam Packet Coy, a descendant of Dr. Thomas O'Connell, *d.c.* 1792 (father of Mary, wife of the Liberator) and a descendant of Dr. Thomas's aunt, Elizabeth, who *m.* Jeremy
